**Explanation of Responses:**

- On November 13, 2020, the reporting person was granted 63,022 Restricted Share Units ("RSUs"). On redemption, 18,214 RSUs were withheld by the Company solely for the purpose of satisfying tax withholding obligations and the reporting person received 44,808 common shares.
- The common shares were priced at \$1.83 Canadian dollars and \$1.3773 U.S. dollars is the equivalent of the purchase price pursuant to the exchange rate as of the transaction date (Cdn\$1.00 = US\$0.7526) as reported by Bank of Canada on its website, www.bankofcanada.ca.
- Each RSU is redeemable upon vesting for one common share.
- The RSUs became redeemable on November 14, 2022.
